BACKGROUND

The American with Disabilities Act (ADA) of 1990 is a Federal Civil Rights Legislation which mandates non-discrimination to persons with disabilities. The ADA, Title II prohibits discrimination by public entities on the basis of disability. Therefore, it is important that the City of Aztec as a recipient of federal funding complies with all applicable federal and state laws, including those protecting persons with disabilities.

In order to accomplish this, the City of Aztec is developing a Transition Plan by conducting a self-evaluation of:

- Its public right-of-ways to ensure accessibility by persons with disabilities;
- Identifying issues of accessibility that need to be addressed;
- Develop a schedule for the improvement of those facilities; and
- Comply with ADA mandated standards for all new construction projects.

The City of Aztec will progressively remove physical barriers to accessibility when facilities adjacent to its roadways cannot ensure access to persons with special needs. Realizing that infrastructure and structural changes will take time and money to upgrade existing facilities, the City of Aztec's Transition Plan includes provisions to include specifications on upcoming design projects, to comply with ADA requirements; giving priority to population concentrations.

The ADA regulations further require the Transition Plan to contain the following elements:

- The name of the official responsible for the plan's implementation;
- A list of physical barriers in the public entity's facilities that limit accessibility of its programs, services, or activities to individuals with disabilities (the Self-Evaluation);
- A detail description of the methods to be utilized to remove these barriers and make the facilities accessible;
- A Schedule for taking the necessary steps to achieve compliance with Title II;
- A schedule for providing Curb Ramps or other Sloped Areas where pedestrian walkways cross the curb and gutter.

ADA POLICY

ADA Policy Statement

The City of Aztec is committed to full compliance with Title II of the Americans with Disabilities Act of 1990 as amended (ADA), Section 504 of the Rehabilitation Act of 1973 as amended (Section 504), 2010 ADA Standards for Accessible Design and all related regulations, laws, executive orders, and directives.

The purpose of the City of Aztec's ADA Policy is to provide guidance for requesting modifications to ensure safe access to the City's programs, services, and activities; and submitting a grievance when the possibility of discrimination may have occurred due to a disability.

Responsible Official

The City of Aztec has designated an ADA Coordinator as the person responsible for the development and implementation of the ADA Policy and the ADA Transition Plan. The city's Public Works Director is appointed as the ADA Coordinator for all Public Right-of-ways (streets, sidewalks, intersections).

Grievance Procedure

This grievance procedure is established to meet the requirements of the Americans with Disabilities Act of 1990 ("ADA"). It may be used by anyone wishing to file a complaint alleging discrimination on the basis of disability in the provision of services, activities, programs or benefits by the City of Aztec. The City's Employee Handbook governs employment-related complaints of disability discrimination. A form is available on the City's website www.aztecnm.gov

The complaint should be in writing and contain information about the alleged discrimination such as name, address, phone number of the complainant and location, date and a description of the problem(s). Alternative means of filing a complaint, such as personal interviews or recordings of the complaint, are available to persons with disabilities upon request.

The complaint should be submitted by the grievant and/or his/her designee as soon as possible but no later than 60 calendar days after the alleged violation to:

Within 20 calendar days after receipt of the complaint, the ADA Coordinator or the designee will schedule a meeting with the complainant to discuss the complaint and possible resolutions.

After an investigation and review, the ADA Coordinator will respond in writing, and where appropriate, in a format accessible to the complainant. The response will explain his/her position on the issue and offer options for a reasonable resolution of the complaint.

If the response by ADA Coordinator does not satisfactorily resolve the issue, the complainant and/or his/her designee may appeal the decision within 15 calendar days after receipt of the response to the City Manager.

After receiving the appeal, the City Manager or the designee will review the appeal and the ADA Coordinator finding. Within a reasonable period of 30 calendar days, after a review, the City Manager or the designee will respond in writing, and, where appropriate in a format that is accessible to the complainant, with a final resolution to the complaint. The decision of the City Manager is final.

Time requirements may be extended upon mutual agreement of the City and individual issuing the complaint.

TRANSITION PLAN

Physical Barriers Assessment

In 2013 the City of Aztec reassessed their road and sidewalk inventory initially developed and recorded within the city's Geographical Information System (GIS). The City is committed to upgrading and implementing ADA regulations and has done so on every road project since enacted by federal regulations. All road improvement projects overseen by NMDOT have implemented and been in compliance with ADA standards at the time of construction or improvement.

The NMDOT has been involved in each phase of the Transition Plan implementation. In addition,

The City of Aztec as part of its maintenance of its GIS system has conducted field investigations and has updated its inventory of public right-of-ways. This information will be used to update this ADA Transition Plan annually.

Identification of Physical Barriers

Access to and utilization of the City of Aztec facilities by individuals with disabilities is frequently compromised by barriers described below. The barrier descriptions are not necessarily exhaustive, but they represent the type of barriers identified by the City of Aztec during our inventory.

In general, the City of Aztec street system provides traveling routes in which local and the traveling public visit public buildings and other services. Sidewalks are the pedestrian travel way, and are frequently obstructed by protruding barriers. Therefore, pedestrian destination from transportation facilities is interrupted, and sometimes not accessible. The following are common barriers noted along pedestrian ways:

1. The presence of Fire Hydrants and other obstructions (utility poles and mail boxes) caused many of the sidewalks to be non-compliant.
2. Many curb ramps had incorrect slopes or lacked detectable strips.
3. Many driveways intersecting sidewalks had incorrect slopes.

The following strategy will be incorporated within the city's maintenance plan for public right-of-ways and facilities:

1. Handicap Ramps. The City of Aztec contracts for upgrading of existing ramps on an annual basis, via its Streets Maintenance Program. These will include ramps at intersections and driveways.
2. Utilities. Whenever a utility relocation, construction or alteration occurs within the public right-of-way, the City of Aztec will ensure that ADA requirements are implemented.

3. Transit. Transit stops are limited within the City of Aztec. The city will access those public stops and develop a plan to correct if such stops are determined out of compliance with ADA standards.
4. Right-of-way Projects. All right-of-way projects involving street and pedestrian ways will be evaluated and designed accordingly with the 2010 ADA standards. All new construction and improvements to existing facilities will adhere to these standards.

Street Intersections

The city's current GIS inventory has identified 242 road intersections from the 182 streets with the city limits. Of these 242 intersections, 102 intersections are now in compliance with the 2010 ADA standards. Eighty-three (83) of those intersections are compliant because they lack pedestrian sidewalks. An itemized listing of street intersections is provided in Appendix A.

Curb Ramps

From the 242 road intersections, 598 potential ramp locations were identified of which 327 were classified as "No Ramps" (lacking curbs with slopes). Of these 327 no ramp locations, 211 lacked ramps because no sidewalks were present to provide for pedestrian crossing. An itemized listing of curb ramps is provided in Appendix B.

Sidewalks

Some 589 public sidewalk segments were identified from the 182 streets located within the city limits. Of these 543 sidewalk segments, 424 were considered non-compliant based on the 2010 ADA standards. An itemized listing of sidewalks is provided in Appendix C.

Targeted Barrier Removal Projects

Upon funding availability, the City of Aztec will implement a barrier removal program within the right-of-way facilities. The program is based on the inventory conducted by the City of Aztec and it constitutes the Transition Plan of accessibility and upgrades.

The top priority of the City of Aztec's Transition Plan is to make the City of Aztec's existing facilities accessible first. The City of Aztec facilities are those which serve pedestrians within the public right-of-ways.

When appropriate, the City of Aztec will replace existing facilities by reconstructing new ones, thereby bringing them into compliance. By following the NMDOT, applicable ADA new facilities and respective upgrades will be included in the projects.

The City of Aztec through its Public Works Department is responsible for the City of Aztec's Transition Plan within the public right-of-ways. Most of the problems within the right-of-ways concern physical barriers that cannot be addressed through other options such as Policy Changes or alternative methods. Therefore, the public right-of-ways can only be made accessible through a realistic and fundable strategy for curb and gutter modifications, wheelchair ramp construction and some sidewalk modifications.

Methods used for Improvements

Standards currently implemented by the City of Aztec, when undergoing new or improvement road projects, adhere to those ADA laws and published under the New Mexico Department of Transportation (NMDOT) Standard Drawings for Pedestrian Access Details for Curb Ramps, Median Curb Details, Pedestrian Islands, Driveways and Driveway Aprons, Stairway and Handrail requirements, Accessible Parking, all aided by a Detectable Warning Surface where applicable.

Schedule for Improvements

The City of Aztec has the responsibility of identifying barriers and implementing a corrective program. As finding to overcome the deficiencies is limited, the City of Aztec has prioritized upgrading of those existing pedestrian facilities based on the City of Aztec's streets improvement plan (Streets Plan 2013). The streets improvement plan considers those streets most utilized and in greatest need of repair and improvements to both vehicular and pedestrian facilities.

The City will annually review the City fiscal allocation for ADA improvements to improve facilities that present physical barriers or to implement ADA regulations in new projects. The City of Aztec will strategically commit, upon fund availability, funding for City of Aztec maintenance projects of its annual allocation, towards ADA compliance projects. In addition, developer impacts on the public's right-of-way can be required to further enhance pedestrian facilities. To date, it is unknown the amount of money that the City of Aztec has invested into ADA Compliance.

Public Input
