Chapter 29 ELECTION DISTRICTS

ARTICLE I. IN GENERAL

Sec. 29-1. Authority.

Municipal elections within the City of Aztec are governed by NMSA 1978, §§ 1-22-3.1 (2018) to Opt-In to the Municipal Officers Election of the City of Aztec in the Regular Local Election. (Ord. 2020-511, eff. 2020-Dec-27; Code 2007, 29-1)

Sec. 29-2. Commission-Manager; Districts for Commissioners; Redistricting.

- 1. The governing body of a municipality organizing under the commission-manager form of government shall district the municipality into five commissioner districts. (NMSA 1978, Section 3-14-6A).
- 2. Redistricting of Commissioner districts can be conducted as specified in NMSA 1978, § 3-14-6B, in the following methods:
 - (1) The governing body of the municipality may redistrict the municipality whenever redistricting is warranted; or
 - (2) Upon petition signed by qualified electors equal in number to the votes cast for the commissioner receiving the greatest number of votes at the last regular municipal election, the governing body of the municipality shall redistrict the municipality. (Code 2007, 29-2)

ARTICLE II. COMMISSION DISTRICTS


Sec. 29-51. Commission Districts Boundaries Defined.

The Governing Body of the City of Aztec, New Mexico, that the City of Aztec, New Mexico has redistricted their five districts. The five districts shall be described as follows:

- DISTRICT NO.1 Bounded on the North by Llano St, S. Main Ave, Blanco St, and Navajo Dam Rd; Bounded on the South by the current City Limits; Bounded on the East by the current City Limits; Bounded on the West by the current City Limits.
- DISTRICT NO.2 Bounded on the North by the current City Limits; Bounded on the South by W Aztec Blvd; Bounded on the East by the Animas River; Bounded on the West by N Light Plant Rd.
- DISTRICT NO.3 Bounded on the North by NE Aztec Blvd, Sabina St, and current City Limits; Bounded on the South by Blanco St and Navajo Dam Rd; Bounded on the East by S Main Ave; Bounded on the West by the current City Limits.
- DISTRICT NO.4 Bounded on the North by W Aztec Blvd, Animas River and current City Limits; Bounded on the South by current city limits and Llano St; Bounded on the East by S Main Ave; W Aztec Blvd, Sabina St, and Navajo Dam Rd; Bounded on the West by current City Limits.
- DISTRICT NO.5 Bounded on the North by current city limits; Bounded on the South by current city limits and W Aztec Blvd; Bounded on the East by N Light Plant Rd; Bounded on the West by current City Limits.
