Commissioner Rogers attended San Juan Safe Communities presentation and the topic was Gang Task Force and what kind of activity is being seen in the area. She mentioned that herself and Chief Heal were asked to do a video to enforce DWI in our community and what the impact could be.

Commissioner Locke mentioned that she will be attending active shooter training. She asked Josh a question on the presentation that Josh gave for the Chamber last week about the fund balances.

Commissioner McClure thanked Kathy Lamb for explaining the financials on the golf course. She reminded everybody about the first annual Steamers and Dreamers event at the Community Center on February 13th.


XV. DEPARTMENT REPORTS


Judge Carlton Gray reviewed the 2015 Municipal Court report with commission.


XVII. ADJOURNMENT

Moved by Mayor Burbridge, SECONDED by Mayor Pro-Tem Sipe to adjourn the meeting at 9:50 pm.


