F. Bid 2017-606 Western Dr. Reconstruction Paving Phase Change Order #1

Mayor Pro-Tem Sipe questioned why it is going to cost \$13,293.80 to get rid of a hump on the construction that was the result of the sewer project. Public Works Director mentioned that the hump needs to be moved to the west so the lower portion of the roadway coincides with the irrigation lateral that runs perpendicular with the roadway which was a part of the design. The design engineer that we hired thought that the hump was going to be included as part of the sewer outfall project which was given to the contractor of the project and the hump was removed and then installed back by the contractor and it wasn't supposed to be so now the change order is to remove the hump again.


Larry mentioned that it was his 12 year anniversary with the City of Aztec as City Attorney.



Moved by Mayor Burbridge, SECONDED by Mayor Pro-Tem Sipe to adjourn the meeting at 6:56 p.m.


