XI. COMMISSIONER, CITY MANAGER, DEPARTMENT REPORTS

He asked if anything had been done in recognition of Nate Chapman who was selected for the naval academy.

Mayor Snover mentioned that the letter was submitted to the High School like in years past, for all the folks that enlisted in whatever branch.

Commissioner Lewis mentioned that he attended San Juan Safe Communities Initiative meeting today it was very informative. He keeps getting requests about mask usage so we need to encourage people to wear masks when they go into businesses.

Mayor Pro-Tem Fry mentioned she also attended EDAB and the piano project hit big and they couldn't be doing it without the chamber. She continues to encourage people to support local businesses and also to join the Chamber or volunteer. She mentioned that they could really use people to help out with some of the projects. She will be turning in the Connie Gotch application tomorrow and hopefully receive funds. She has MPO on Thursday and she was unable to attend the NWNM seniors meeting. There will be another one as they finalize the transition from dissolving that organization and the City of Farmington will be taking on overseeing funding for the senior centers throughout the county.

Mayor Snover mentioned that he was out of town and missed the Airport Advisory Board meeting and even though he is not a voting member he agrees that it is important, he has the next meeting on his calendar. He has an ECHO meeting tomorrow and he is pleased and impressed with the team that ECHO has throughout the state.
