# B. Special Budget Resolution 2022-1307

Anthony Bolling provided Commission with a breakout of the request for the Special Budget Resolution. The City received a Title III Grant from the City of Farmington and with the ARPA funding it came in about \$50,000 dollars above budgeted estimates.

C. Law Enforcement Fund Grant Agreement

Chief Michael Heal explained the grant that was approved by the Governor that could provide the city of Aztec with an additional four officers at \$75,000 per officer per year. The total amount that was awarded to the city of Aztec was \$525,000 dollars. Commission was provided a copy of basic information showing the breakdown in which the salaries will be paid including the City portion.

The commission had questions concerning the obligation and liability of the City if the salary isn't expended by June 30<sup>th</sup>. Anthony Bolling explained that he believes if it is not expended the City would just not receive those funds.

# COMMISSIONER, CITY MANAGER, DEPARTMENT REPORT

Anthony Bolling reported that the GRT for the month of September was \$553,725.86, gas tax was \$94,411.94, and compensating tax was \$20,233.66 which is 10% above the budgeted amounts and 5.73% above last year and \$19,016.26 came from the sale of cannabis.

Mayor Padilla stated that he is working with a committee who are trying to secure funding for a project from Hwy. 173 to Navajo Dam. He asked Commission to approve a Resolution of support, with the County being named the fiscal agent. He thanked staff for the hard work getting a Planning and Zoning Board put together. He also discussed the City Manager hiring process and the planning of upcoming meetings with the referral committee.

Commissioner Crowley suggested possibly scheduling a retreat in October. He reminded Commission of the constituent who had concerns of the flooding in Kokopelli, Interim-City Manager is aware of the situation, and it is being addressed.

Commissioner King brought up the Alzheimer's walk held over the weekend and was pleased with the community turn out.

Interim-City Manager Jeff Blackburn reminded Commission of the closed session on October 11<sup>th</sup> regarding pending liabilities and cases. He provided Commission with a project document regarding what is being discussed at the meetings held every Thursday in the Commission room. Jeff stated that there will only be one meeting in November and one in December. He has also gone to the MVD to observe the daily operation and they are doing an outstanding job.

Library Director Angela Watkins described the conference she attended in Tennessee and the ARSL organization that she is part of.

Constance Hutcheson from the Senior Center announced the fund raiser they are doing, it is Vegas themed and will be on October 22<sup>nd</sup> for 7:00pm-11:00pm.

Community Development Director Steven Saavedra stated there are currently bids being putting out for construction work on new Maverick being built.
