# BUSINESS ITEMS

A. Local Economic Development Act (LEDA) Application Request for Jacks Plastic Weld

Mayor Padilla mentioned the changes to the application to include land acquisition, and the amount of funds from \$300,00.00 up to \$400,00.00.

### COMMISSIONER, CITY MANAGER, DEPARTMENT REPORT

Commissioner Crowley suggested that the Commission give direction to the City Manager on the processes for hiring a new Police Department Chief. Mayor Padilla would like to go through the hiring process, then address any other issues after they hire the new Chief. Jeff stated that they will have the process for hiring the Chief very soon. Commissioner Crowley asked about the trash in the parks, he would like to have an Ordinance put in place to stop the dumping. He also mentioned the utility billing for the Senior rate, there is a flyer going out in the current bill with the information. Jeff mentioned it will be sent to Steve Murphy to review the verbiage before it is sent out.

City Manager Jeff Blackburn reminded Commission of the NMML Annual Conference August 29<sup>th</sup>-September 1<sup>st</sup>. Waste Management has invited Commission to a mixer at No Worries Sports Bar and Grill from 7:00-9:00pm August 29<sup>th</sup>. He mentioned the meeting scheduled for Thursday with NMDOT regarding the Arterial. Jeff presented Commission with the June GRT report and the revenue budget. He gave an update on the entrance to the Motocross and mentioned they will host a demolition derby at the end of the month.

Mayor Pro-Tem George inquired about the BLM request for the 5 acres, Ed Kotyk stated there is currently no timeline.

Jeric Jaramillo reported to Commission that they have submitted everything regarding Reservoir 1 and the Arterial they are just waiting for the funds to be obligated, it should be around September 18<sup>th</sup>. They had a meeting with engineers, the City of Bloomfield and San Juan County regarding the water line replacement south of the city, they are hoping to find funding for that project. He attended training with the NMDOT that was very informational. Mayor Pro-Tem asked about McWilliams Road, Public Works Director Ruben Salcido let him know they are still working on locating the 10-inch pipe.

Electric Director Denver DeWees informed Commission that they have received a grant from the Energy Department for \$170,00.00 for the new solar field.
