The Commission has requested that the Community Development Director Andrew DiCamillo amend the ordinance by changing some language on the permitting section, appeal section and review the application fees. The ordinance will be updated and submitted for final approval of commission in the November meeting.

Andrew clarified that the sign code has needed revision for some time and that is what they are trying to get done in amending ordinances. The Commission suggested possibly scheduling a workshop to review the draft Ordinance after revisions are made.

COMMISSIONER, CITY MANAGER, DEPARTMENT REPORT

Mayor Padilla commended General Services Director Charles Dobey, his crew and all volunteers for the hard work they put in for the Highlands Games. He also asked Commission to give direction to the City Manager as City Attorney Steve Murphy has agreed to a month-to-month contract until another attorney is hired. He informed the Commission of the concerns he has encountered regarding the purchase of the John Chaffey property. Andrew DiCamillo let them know that it is in the process but has not yet been purchased.

Mayor Pro-Tem George would like to sit in on the interview for the attorney that applied for the City Attorney position. Steve Murphy believes that the RFP for City Attorney should go back out since

there was only one application and should be advertised in more places. Mayor Pro-Tem would like to schedule a round table/retreat for discussion on the direction of the Commission.

Commissioner Crowley would like to see the addendum to Steve Murphy's contract come before the Commission. He reminded the Commission that house addressing is very important for first responders. He also would like to schedule a time to do the City Manager's review, Mayor Padilla would like to schedule it before the end of the year. Commissioner Crowley gave an update on 4CED, they are still looking for a new CEO.

Commissioner King also commended Charles, PD, and staff for their work on the Highlands Games

Commissioner Randall mentioned that early voting started today.

City Manager Jeff Blackburn let Commission know that Waste Management is sponsoring a tent at the balloon fiesta. He also presented Commission with the City's current monthly financial status and quarterly report.

Electric Director Denver DeWees gave an update on projects that the Electric Department is working on;

- Submission of quote and final review for the museum
- System improvements
- Pole replacements
- Hwy 173 TND services have been retained for the project.

Community Development Director Andrew DiCamillo updated Commission on his department;

- Residences are being constructed around the city.
- EDAB updates, 2 applications for in house economic fund have been submitted.
- Global Site Selection Conference he attended.
- Water Commission Board meeting, water line extension between Aztec and Bloomfield was discussed, they would like to be involved.

Public Works Director Ruben Salcido updated Commission on his department and projects they are working on;

- Staffing, maintenance is fully staffed Water division lacks one.
- Arterial and reservoir projects have seen no movement from the State.
- McWilliams Road price increase
- Hwy 173 findings have been completed.
- In house projects for asphalt on Pueblo and Ute and on Anasazi.

Finance Director Jennie Achee presented Commission with an audit update; the auditors sent a confidential MEMO to Commission with their update.

Interim Police Chief Joseph Gonzales updated the Commission on what is going on in his department;
