E. City Manager Evaluation Process

Mayor Padilla and Commission are currently working on the evaluation process, he asked Commission if they would like department heads to evaluate the City Manager. Commissioner Crowley believes that it should be left to the City Manager for evaluations to come from within directly to the City Manager, not through this evaluation process. Mayor Pro-Tem stated that allowing department heads to evaluate the manager should be allowed, it was done with the previous manager and allowed Commission to give better direction to the Manager. Commissioner King had some reservations about allowing it but would not be opposed. Commissioner Randall also believes that the department heads should be allowed to do the evaluation.

Mayor Padilla mentioned Jeff's contract which states Jeff must agree with the process that Commission is presenting and mentioned section 5 of Jeff's contract stating that he does not want to violate it. The mayor asked Jeff if he agreed with the process, Jeff stated that he agreed with it, but would like to remove Ed Kotyk from doing the tally sheet and have a commissioner do the tally. Commissioner King agreed to complete the sheet.

Mayor Padilla informed every one of the time frame for the evaluations:

- 11/28/2023 all evaluations to be turned in from both Commission and staff
 Commissioner King and the Mayor will then review them to present to Commission.
 Commissioner King will be compiling the tally sheet.
- 12/12/2023 Final evaluations will be given to Commission.

Mayor Padilla stated that they can do the actual evaluation in either an open or closed meeting and asked for direction from Commission. Commission decided that it should be done in a closed session. City Manager stated that he has full confidence that Commission will do a fair job and has confidence in the job that he is doing, so he is impartial to an open or closed session.

COMMISSIONER, CITY MANAGER, DEPARTMENT REPORT

Mayor Padilla thanked everyone who turned out to vote, and reminded Commission that the Senior Center is still needing donations for the Thanksgiving community dinner.

Mayor Pro-Tem asked City Manager if Commission can give money to the Senior Center out of their discretionary fund for Thanksgiving. Jeff asked Finance Director Jennie Achee for direction on the matter, she stated that they can move the money from one account to another and have a resolution for it on the next meeting agenda. Mayor Pro-Tem questioned if the City would be helping with Sparkles, Jeff let him know that the electric department is working on a float. Mayor Pro-Tem also questioned if Commission will be doing the lighting contest, Jeff informed him that the Chamber will be doing it this year.

Commissioner Randall let Commission know he will not be able to attend the annual Christmas party or Sparkles this year. He also recognized the Police Department and the great job they are doing.
