#### COMMISSIONER, CITY MANAGER, DEPARTMENT REPORT

Commissioner Randall reported that NM Game and Fish have restocked Riverside and Tiger Pond. He thanked City employees for their hard work keeping the city going when the weather gets bad.

Commissioner Crowley also thanked staff for their hard work and dedication on keeping the city running and safe during severe weather.

Mayor Pro-Tem thanked the Public Works crew for the snow clean up.

Mayor Padilla sat in with property owners on the North Main extension, they attended the EDAB board meeting and discussed their plans with the property they have purchased. He also mentioned the email that the Commission received regarding Reservoir I. He mentioned that it was not on the agenda to be awarded as the consent letter from the State had not been received.

City Manager Jeff Blackburn updated the Commission on the following:

- GRT update and financial overview of the City is \$10,132.00 under the projected budget, but up 2.4% from last year.
- Commission retreat is scheduled for January 18<sup>th,</sup> the agenda is being worked on and they have reached out to find a facilitator.
- Update on The Resolution that was tabled in November that it will be on the next commission meeting agenda.
- Reminded Commission that there will be a projects meeting on Thursday if weather cooperates.

Project Manager Jeric Jaramillo gave an update on the consent letter from the State regarding Reservoir I. He has not yet received the letter but has a conference call on Thursday to find out the status of the letter. He informed Commission of the bid opening for the McWilliams Road project which is scheduled on January 23<sup>rd</sup>.
