2023 Chip Seal Inspection Report Clayton Harrison

Clayton Harrison presented the Commission with a PowerPoint pertaining to his inspection of the chip seal project that was done in September 2023. Commission had questions regarding the finished project. Clayton also gave some suggestions on other types of solutions to fix the roads. Public Works Director Ruben Salcido will do an inspection of the drain that they have concerns about. Jeff asked Clayton what he believes the city should do moving forward. Clayton believes that the city should review the road plan and look for funding for future road projects.

Mayor Padilla learned the company did not come back and sweep as they should have, and he believes that is what caused the issues. Mayor Pro-Tem George asked Clayton if the city got its money worth out of the project. Clayton reported that we did and that by the contractor's error we received more square yardage for free. Commissioner King asked if Clayton felt like doing the chip seal caused any damage to the roads and Clayton said he did not feel like it did.

COMMISSIONER, CITY MANAGER, DEPARTMENT REPORT

Mayor Pro-Tem asked Chief Joseph Gonzales about the rumors regarding numerous dog shootings over the last 3-6 months. Chief Gonzales did not have

knowledge of this, he has only heard of two incidents, one where an individual shot several of their own animals and another where an owner put down a sick animal, but he will investigate further.

Commissioner Crowley informed Commission that Senator Neville will not be running again that he is retiring. He also mentioned that he spoke to Clinton Nicely regarding a current news article and his concerns with settling cases. He does not believe that just settling is the best route that the City should take. Mayor Pro-Tem George also found the articles concerning and has been fielding calls from constituents. City Manager Jeff Blackburn said he has no concerns at the Animal Shelter, he believes Tina is doing an excellent job.

City Manager Jeff Blackburn had updates for Commission on the following:

- Presented Commission with the GRT report.
- New Counsel, Nann Winter was introduced to staff today.
- He attended the new Detention Training Center on the 30th.

Project Manager Jeric Jaramillo gave Commission project updates on the following:

- Pre-Construction meeting for Reservoir 1 went well they have the contractors signed contract, will have the City's signed this week and notice to proceed sent out next week.
- McWilliams is waiting for final authorization from the grant agency, and then will present the notice of award at the next meeting.
- There is a change order submitted to CES for the Anasazi project for the expanded area by the valley gutter that is awaiting approval.
- Ute/Pueblo project initial contract was under \$60,000 but went over, so he will be bringing it before Commission.

Mayor Pro-Tem had questions regarding Bixby Electric's overrun at the airport for lighting and labor for that project. Wallace informed him that they had to get an additional inspection done.
