
Mayor Pro-Tern Cortez: Library Board, Personnel Committee Alternate MPO, and COG Alternate

Commissioner Lanier: EDAB, 4CED, San Juan Water Commission, COG and County Commission Representative Alternate


Commissioner Buchholz: Personnel Committee, 4CED Alternate, Northwest NM Seniors, and ECHO


