

**City of Aztec  
Ordinance 2026-566**

**Amending Chapter 16, Section 16-211 Solid Waste and Recycle Rates**

**WHEREAS**, RFP 2019-672, Municipal Solid Waste Services, was approved by the City of Aztec Commission and was awarded to Waste Management of New Mexico in January 2019 and terminates the last day of February 2023, with an automatic extension of 4 years beginning March 1, 2023, and extending an additional 4 years. This will terminate on the last day of February 2027.

**WHEREAS**, pursuant to Section 42 of the agreement between Waste Management of New Mexico and the City of Aztec, a request for rate adjustments has been submitted timely; and

**WHEREAS**, this amendment will continue solid waste services to commercial and residential customers. Residential services include access to the San Juan County landfill six times per year, two bulky item pickups per year, and At Your Door service for hazardous waste disposal.

**WHEREAS**, residential recycling will continue to have an every-other-week pickup service.

**WHEREAS**, rates will be effective with the March 2026 billing.

**NOW, THEREFORE, BE IT ORDAINED** by the Governing Body of the City of Aztec, New Mexico, that the intent to adopt Ordinance 2026-566 Amending Chapter 16, Section 16-211 Solid Waste and Recycle Rates be adopted as attached.

Rates include Service provider costs and utility administration fee. Contractual allocation-up to 24 free 30-yard hauls for general services facility, 307 S. Ash, Aztec NM and 10 free 30-yard hauls for community wide clean ups during contract year. The city will pay disposal on all hauls.

**5. Residential Curb Side Recycling Service.**

Rates include Service provider cost and utility administration fee. Per Waste management Agreement Amendment #2, Article III. Contractor Provisions, Section 28. Recycling Services, Subsection B. Residential Recycling, the Contractor shall supply one free initial container for residential recycling to each residence requesting such a container. All residential customers will be billed for recycling services regardless of whether the customer requests a recycling container.

**6. CPI Adjustment.**

The solid waste and recycle rates will be reviewed and adjusted annually to reflect increases in the Consumer Price Index for All Urban Consumers; Garbage and Trash collection services (CUUR0000SEHG02), as, published by the United States Department of Labor, for the 12 month period ending November 30.
