**Parade line-up will begin at 5 PM. Entries will not be allowed in the line-up area before 5 PM. Please report to staging area Mesa Verde Avenue between Chaco and Chuska Street to sign in and receive your judging number.**

- If you are dropping off parade participants, please be prepared to exit the staging area immediately. Only vehicles in the parade will be allowed in the staging area.
- If you have several vehicles in your entry, please arrive at the line-up area **at the same time**. Late entries will not be allowed to participate in the parade.
- **All floats must be decorated before entering the staging area** due to time and space constraints.

In order to address safety concerns, the Aztec Police Department has issued these rules and regulations for all parades in Aztec.

- **You may not throw candy to the crowd from your float!**
- **You may walk the parade route with your float and hand out candy.**

We understand that it is fun to interact with the crowd. We encourage you to have fun but please do so in a safe manner.

Santa Claus will be attending our parade, so **PLEASE do not include a LIVE Santa** on any entry.

We are looking forward to a wonderful parade. Our wish is for everyone to have fun and to be safe.

## CITY OF AZTEC

### Use of Facilities Waiver of Liability, Assumption of Risk and Indemnity Agreement Waiver

In consideration of permission to use the facilities, staff, equipment, and services of the City of Aztec, New Mexico ("City"), in addition to the payment of any fee or charge, I \_\_\_\_\_ ("Participant"), acknowledge that I have voluntarily applied to participate in the following activities at:

#### Assumption of Risk

This use of the City's property, facilities, staff, equipment, and/or services carries with it certain inherent dangers and risks that cannot be eliminated regardless of the care taken to avoid injuries, accidents, or illnesses (including death) and damage to property.

I hereby release, waive, discharge, and covenant not to sue the City and any and all its directors, officers, employees, and agents (together, "City") from any and all claims including negligence of the City resulting in personal injury, accidents or illnesses (including death), and damage to property arising from, but not limited to, participation in activities, classes, observation, and use of facilities, premises, or equipment at \_\_\_\_\_.

I have read the previous paragraphs and I know, understand, and appreciate these and other risks that are inherent in the activities made possible by the City. I hereby assert that my participation is voluntary and that I knowingly assume all such risks. I also affirm that I have adequate medical or health insurance to cover any medical assistance I may require and that I am in good health and have no physical or other impediment which would endanger me while using City facilities, premises, or equipment.

#### Indemnification and Hold Harmless

I further agree to indemnify and hold the City harmless from any and all claims, actions, suits, procedures, costs, expenses, damages and liabilities, including attorney's fees brought as a result of my use of facilities, premises, or equipment at \_\_\_\_\_ and to reimburse them for any such expenses incurred.

#### Severability and Choice of Law

The undersigned further expressly agrees that the foregoing agreement is intended to be as broad and inclusive as is permitted by New Mexico law and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect. I further agree that this *Release* shall be governed for all purposes by New Mexico law, without regard to such law on choice of law.

#### Acknowledgement and Understanding

I have read this waiver of liability, assumption of risk, and indemnity agreement, fully understand its terms and understand that I am giving up substantial rights, including my right to sue. I acknowledge that I am signing this agreement freely and voluntarily and intend my signature to be a complete and unconditional release of all liability.
